



Regulations VeloSoleX 2020

General information

The event VeloSoleX 2020 is organized by the association VeloSoleX Switzerland (hereinafter: organizer) and is held in all weathers.

Registration

The registration with the different participation options takes place via www.velosolex-schweiz.ch. Information on the registration procedure and the various participation options can also be found on the aforementioned homepage. Registration is possible from 1 January 2020. The number of participants is limited to 350. Registration is based on the date on which payment of the participation fee is received.

A claim for reimbursement of the entry fee only exists in the event of cancellation of the event. Especially in case of non-appearance, delay, illness or accident, a vehicle which is not in running order or any other violation of the starting conditions, participants have no right to a refund.

The event will take place in all weathers. The organizer reserves the right to shorten the route on Saturday in case of bad weather conditions.

Driver briefing

All relevant information about the event (schedule, route, etc.) is published on the website www.velosolex-schweiz.ch and can be viewed there. On arrival, a programme booklet with the detailed route and all other necessary information will be distributed.

Starting conditions for man and machine

- Valid motor vehicle identification card and licence plate for the Velosolex.
- Valid driving licence for the category motorbike or car.
- Obligation to wear a helmet according to Swiss road legislation (see Art. 3b of the Swiss Traffic Regulation Ordinance, VRV).
- The Velosolex complies with the requirements of the Swiss road traffic legislation. Among other things, it must have lights at the front and rear and the brakes must work at the front and rear.

Rules of conduct for driving in a convoy

- Only overtake on the left and give a hand signal before doing so.
- Keep your distance.
- Do not drive into the oncoming lane.
- If there is an extraordinary stop, leave the road at a suitable place.
- The support vehicles are respected. The leader is not overtaken.
- Right of way, red lights and normal traffic rules must also be observed in the convoy.
- The instructions of the accompanying vehicles of the organizer must be followed.



Breakdown?

- If your Velosolex or you run out of breath or have an emergency message, dial the appropriate emergency number:

VeloSoleX Switzerland (*will be announced before the event*)

Police 117, Paramedics 144, Fire Brigade 118

- If you are stranded on the track, the support vehicle will collect you. The support vehicles will give you instructions.
- In case of traffic accidents the convoy will continue. Only victims, persons possibly responsible for the accident, witnesses, helpers and a support vehicle remain on site.

Liability

Participation in the event is at your own risk. Insurance cover is the responsibility of the participant. The participant confirms with his registration that he is in possession of a valid accident and liability insurance. It is the participant's sole responsibility to ensure that his vehicle is safe to operate and complies with the requirements of the Swiss Road Traffic Act. Each driver undertakes to comply with the applicable road traffic legislation. Any liability of the organizer is excluded. The organizer also excludes any liability for auxiliary persons.

If, in the opinion of the organizer, the event is endangered by force majeure, the organizer reserves the right to cancel the trip without responsibility or liability for the amount or type of loss or damage that a participant could suffer directly or indirectly as a result. In the event of cancellation of the event due to force majeure, the liability of the organiser shall in any case be limited to a maximum of the reimbursement of the participant's contribution.

Competition and Tombola

A competition and / or tombola will be held on the occasion of the event. Participation in the competition is open to all participants of the VeloSoleX 2020 event. Excluded from participation are: the organizers (and their relatives), their assistants and possible contractors.

The raffle will take place on the occasion of the event. In case of questions of interpretation the organizer decides. Legal recourse is excluded. The winner will be announced on the occasion of the event. If he/she is not present, he/she will be notified in writing.

No correspondence will be entered into regarding the competition and / or tombola. An exchange or a cash payment of the prizes is excluded. The allocation of prizes cannot be contested.

The data of the participants of the competition and / or tombola will only be used for this competition.

The organizer reserves the right to cancel or terminate the competition and / or tombola at any time. This applies in particular to cases in which technical or legal reasons make it difficult or impossible to hold the competition and / or tombola.



Data protection

By registering you confirm that the personal data you provide in connection with the VeloSoleX 2020 event is correct and up-to-date. You accept these regulations and agree that the organizer may use your personal data. Personal data, photos and videos will only be used for purposes in connection with the VeloSoleX 2020 event and will only be stored by the organizer and its commissioned data processors for as long as necessary. This may include a period of time after the end of the event to award prizes or to clarify legal questions. The organizer and its contractual partners may contact you regarding the VeloSoleX 2020 event by e-mail, telephone or other means. You have the right at any time to request a change and/or complete or partial deletion of such personal data. In this case, the organiser will ensure that such data is deleted as quickly as possible. In addition, you have the right at any time to request information about the personal data retained by the organiser.

Regulations

Changes in the regulations can be made at any time and are reserved for the organizer. The current regulations can always be found on the website. However, participants are obliged to gather this kind of information themselves.

In the event of contradictions between the English, French and German versions of the respective conditions, only the German version shall be authoritative.
